ABOUT THE GALLERY

SALES

Works do not have to be available for sale however for works that are sold during the exhibition, ECA+ requests a 25% commission.

The ECA+ Gallery will promote the exhibition through press releases, social media, e-newsletters, ECA+ website, and other arts and media websites. A reception for the exhibition will coincide with Art Walk Easthampton, the second Saturday of each month from 5 - 8 p.m.

Terms of Exhibit

1. All works must be presented professionally. 2-dimensional works must be ready to hang. Artist must provide pedestals for 3-dimensional work.
2. Delivery and pick-up of the work is the responsibility of the artist.
3. Installation of the exhibit is done in collaboration with the artist and ECA+ Coordinator.
4. Works delivered must be similar in nature and quality to images submitted in the original proposal. If the work changes, ECA+ must be notified and updated. Works to be exhibited are subject to final approval by ECA+.
5. Insurance is not provided in the ECA+ gallery. Artists are responsible for insurance or may exhibit works at their own risk.
